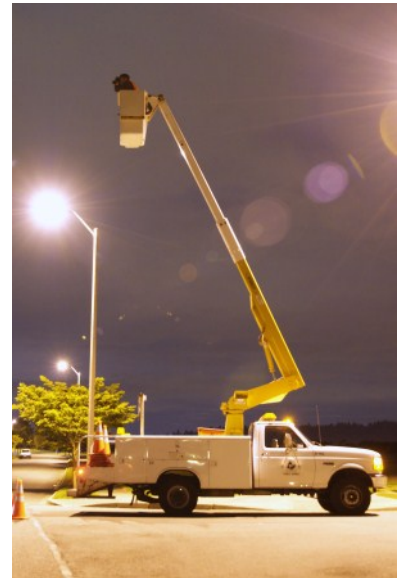

Scribe Report

December Meeting (Tuesday, 12/13/2011)

Normally I pride myself on being able to find my way to most destinations by car. Ever since I was little, I had a keen sense of direction. With today's smart phones, the task of finding an unfamiliar meeting location becomes ridiculously easy. But for some reason, my phone let me down as I hunted for the Tukwila Community Center (TCC) for this month's training session and breakfast meeting. The phone told me to turn into the wrong business complex and my sense of direction was at war with the route my phone plotted for me. Not less than two U-turns later, I managed to find the right destination and realized the driveway of my first U-turn belonged to the TCC. Fortunately, the struggle to locate the Center was well worth the drive as the small meeting room had a great view of large green spaces fronting the Green River. With my pride dented, I found a good parking spot and joined other members as the breakfast buffet prepared by Landau's catering was being readied. I just hoped the speaker wouldn't focus on possible distractions while driving.



Section president, Kevin Chang, started the meeting at 9 am by asking for self-introductions for newer members and those attending from Vancouver and Olympia, Washington. He then announced information on January's meeting at the Nile Temple and a job opening at King County.

Mr. Chang then handed the meeting to Garry Norris, DN Traffic Consultants, to moderate the training session. Mr. Norris related to the members the ITE meeting in Orlando where he was introduced to the impressive topic to eliminate all fatality collisions. When asked "What is an acceptable number of fatalities a year?" a State (Utah) might respond with 200-300 per year. If an individual were asked what is an acceptable number of family members killed per year, the perspective changes. Mr. Norris continued by showing a video showing a U.N. effort to focus on pedestrian safety internationally and can be viewed at www.makeroadssafe.org.

Immediately following, Mr. Norris introduced Lowell Porter, Director of Washington Traffic Safety Commission, to talk about Washington State's effort to reduce the number of fatalities. Mr. Porter began with the Target Zero Program that began in 2000. Starting with a goal, there has to be a first step. If we start with 640 fatalities this year and our eventual goal is to have zero. Our first step may well be to "only" kill 600 people next year. Instead of believing we can't get there from here, countermeasures focusing on highest percentages of contributing factors lead the way to marking a significant reduction on fatalities from 2005 to current and a means to continue the trend to the eventual goal to be realized by 2030.

Rather than looking at the typical pin diagram for high accident locations, a larger pool of data was examined. Looking at the statistics, half of the fatalities were in daylight hours yet the volumes or vehicle miles traveled were 85% of the total versus the dark hours. 36% of fatalities involved unrestrained occupants and 22% in-

Safety Corner: ITE-WA Section to Partner with Target Zero

As a follow-up to the December safety training meeting in Tukwila, which included presentations on the national “Toward Zero Deaths” initiative and the State of Washington’s “Target Zero” program, the ITE Washington State Section Board is planning on formally requesting that ITE-WA be added to the list of recognized Target Zero partners who support the program’s goal to end traffic deaths and serious injuries on our State’s streets and highways by 2030.

Lowell Porter, director of the Washington Traffic Safety Commission, outlined the progress and beneficial impacts of the Target Zero program at the training. As a part of his presentation, Mr. Porter described the vision, leadership, and innovation that have made Washington State a national leader in reducing fatalities and serious injury crashes. He also showed how, based on the reductions experienced in recent years through education, enforcement, and engineering initiatives, the goal of reaching zero fatalities by 2030 is attainable if the current annual rate of reductions in fatalities is sustained over the next two decades.

Those in attendance at the training participated in an informal straw poll on if ITE-WA should be added to the list of partners in the Washington State Target Zero program, and there was consensus support.

Washington State is building traffic safety partnerships throughout the state to align priorities and leverage resources to improve traffic safety. “Target Zero” is the outgrowth of that partnership, setting forth a vision to reduce traffic fatalities and serious injuries. It identifies Washington State’s traffic safety needs, helping to guide investments through data-driven decisions to achieve significant reductions in traffic fatalities and serious injuries on all public roads.

involved legally drunk drivers. These facts helped to narrow the focus for special patrols that took the fight to the night. Targeting drunk driving and ticketing seat belt violators during the dark hours allowed the small program to yield significant results in the State’s fatality rate.

Calculating the social cost of fatalities and serious injuries, addressing the over-represented contributing factors in such systematic manners can easily justify the expense of such programs. Using this data driven and evidence based approach, the State now looks to be able to chip away towards zero. We can get there from here.

A short question and answers session followed. Gary Norris then invited Brian Chandler, SAIC, to talk about another approach to identify and address fatality collisions. Mr. Chandler shared the experience from the state of Missouri.

Again the typical pin diagram of high accident locations only told the randomness (state-wide) of collisions by location. But if we were to extract the over-represented types of collisions such as right angles and left turns, the focus for countermeasures can be narrowed. Mr. Chandler continued by providing examples of countermeasures and answering questions as he spoke.

After another round of questions and answers, the meeting was adjourned. For the drive back, I decided to leave my phone in its case after viewing instructions on how to get to I-405 and then revert back to my senses while behind the wheel and started scanning for right angles.

The awards are not limited to behavioral change efforts but celebrate achievements in all efforts that contribute to reducing traffic fatalities and serious injuries on all public roads.

Categories

The award categories match the objectives in Priority One and Priority Two levels of the 2010 Target Zero:

- Impaired Driving
- Run-Off-Road Crashes
- Speeding-Involved Crashes
- Young Drivers
- Unrestrained Occupants
- Distracted Driving
- Intersection Crashes
- Traffic Data Systems

Judging

Judging criteria comprise the use of proven strategies, best practices or innovative strategies with a strong evaluation component. Judges may include traffic engineers, law enforcement professionals, the judiciary, traffic records experts and emergency medical professionals.

Eligibility

Any business, not-for-profit or government organization in Washington, or any individual or group within such an organization, is eligible to submit an entry. WTSC employees are not eligible to receive awards.

Entry Submissions

Entries may be submitted by the achieving person or group or by a nominating person on behalf of an individual or group.

All entries must be delivered to the Washington Traffic Safety Commission by U.S. Mail or courier by 12 noon on Thursday, January 12, 2012.

Each entry must be entered in only one category. On the outside of the envelope/package, note the name of the category.

Entry Content

Each entry comprises a document that answers the questions below ("Entry Form") and supporting materials. Place the entry form in front of other materials. The nature of supporting materials may vary significantly, but might include CAD drawings, photos, news clippings, letters of commendation, affidavits, marketing communications materials or database queries/reports. Clearly label all materials with the entry name.

If any entry individual or group wants supporting materials returned, an appropriately-sized, self-addressed envelope/package must be included in the submission.

Entry Form

Answer the following questions in the order presented. The entry form is the heart of an entry, so answer the questions thoroughly, yet concisely.

- 1) Category (e.g., Distracted Driving, Intersection Crashes)
- 2) Entry name (e.g., project/program title, individual/group name)
- 3) Contact information for person submitting entry, including name, email address, phone, and mail address
- 4) Identify the project, program or effort. This is the executive summary of the entry that describes
 - a) the situation or problem
 - b) actions taken
 - c) the result
- 5) Specify the proven strategies, best practices or innovative strategies with a strong evaluation component used

The workshop is free but pre-registration is required. In the event that lunch will be provided, those who have registered will be notified accordingly.

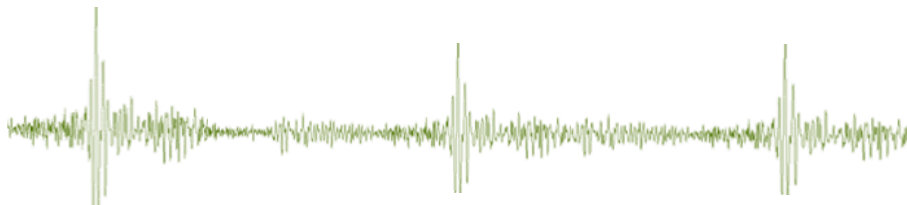
